The Fire Department is looking into a USDA grant to finance new structure engines. The Highlands engine and the ambulances continue to break down. Central Lyon Fire has loaned their backup engine for the Highlands Station.

The Fire Dept. is also updating the memo of understanding with the Virginia City Highlands Home Owner's Association for fuel management.

Directed staff and requested the District Attorney to work with Washoe County to explore the potential County boundary line adjustment on land adjacent to the Truckee River and owned by the Tahoe-Reno Industrial Center.

The Planning Commission has completed two sign sweeps in an effort to bring signage into compliance.

The air release valve project on the Marlette pipeline is 90% complete.

Two Reserve Deputies have graduated from the academy.
